### DUES INFORMATION & POLICIES

The Metropolitan Washington Association of Independent Insurance Agents Dues year is September 1 to August 31 annually.

Dues for the association are calculated per agency on a base of \$350 + \$50 per employee. Maximum per agency is \$1,500 (excluding Trusted Choice Dues).

Trusted Choice dues are \$60 for agencies with 1-9 employees, \$120 for agencies with 10 or more employees.
